5. Implementation of Odorous Industries Nuisance By-law

a) Update on Contingency Odour Mitigation Plans received in accordance with the Odorous Industries Nuisance By-law (5b).

The Town received submissions from the CannTrust and Redecan facilities regarding their odour mitigation. P. Girard completed a review and advised each are deficient. By-law has reported back to each facility and the Town awaits response.

b) Discuss resident odour complaints.

B. Lymburner reported an overview of odour complaints received year to date. The By-law Department received 57 complaints, conducted 210 random air quality tests and issued 2 warnings when readings were close to the odour unit threshold of 6 at the facility property line. He advised the committee that facilities have cooperated with them, and the By-law Department is available to receive all complaints from the public.

The Committee noted that many residents are unable to use the present PSR system; and staff progress towards a planned PSR replacement has been challenged during COVID-19.



6. Legal Actions Update

B. Wiens provided an update of the ongoing legal actions. The appeal of the extension to the Interim Control By-law was withdrawn and OLT has closed their file. Council to provide direction on other legal proceedings.
