#### **6. Two-Eyes Seeing Training – Natalie Seniuk to Discuss**

##### **6.1. Two-Eyed Seeing – Importance**

Natalie attended the Two-Eyed Seeing training the week of March 12, 2024.

Natalie gained knowledge regarding Western and Indigenous learning and the importance of understanding each other's knowledge without prejudice.

The training touched significantly on climate change and how we can adjust our reactionary ways to better suit our needs.

The training also touched on how we can adjust our thinking to be broader and how that will benefit more than one specific ideal. Designing and thinking of things pertaining to 7 generations (forward and back) and how it will affect those after us and looking at what those before us did in their practice.

Ethical Space: Where different knowledges can come together and work together and respect each others' perspectives without judgement.

The Committee offered to assist the Town with decision making with NCC (Nature Conservancy of Canada) and NPCA (Niagara Peninsula Conservation Authority) property that was recently acquired.

Mike Jones spoke about how Pelham PATH is planting \$8000 worth of trees in the Lathrop property. There is an agreement that these trees are to be planted in the fall over three weekends.

## 9. Other Items

Mike Hoch did research into residential Heat Pumps. Mike noted that heat pumps are significantly more expensive than replacing a furnace. Heat pumps do not eliminate a gas or electric furnace in cooler climates as they are not capable of producing heat below -10 degrees c. Making installing heat pumps solely in new Canadian homes ineffective.

The potential for a member of the committee to be on the NCCAN committee.

Town of Pelham Tree Protection: How to protect the trees, specifically Significant (heritage) Trees within the Town. Research if there are local by-laws that require permitting for removal of trees on private property. What will the permeameters be for this by-law? Fort Erie recently released a by-law for Trees. The communication with the public would have to be significant to avoid push back if the Town were to consider this.
