6. Guest Speaker: Greg Lewis (President of Pelham Cares)

Greg Lewis President of Pelham Cares Inc. shared with the Committee that Pelham Cares Inc. is not just a food bank. The services provided have evolved from providing food and friendly visits to include food, personal hygiene and household items, transportation to medical appointments, the sponsorship of youth to enable their participation in sports, recreational and educational activities, and information and referrals in response to emergency situations. Greg Lewis encourages the committee to share information with the community regarding the services Pelham Cares provides such as:

• Providing backpacks with school supplies and school snacks to children of our registered client families, at 'back-to-school' time. This year Pelham cares provided 94 backpacks to families in the community.



- Providing referrals to other social service organizations/agencies which do not have a visible point of contact in Pelham. Providing information about related organizations/agencies/services to the public.
- Client individuals and families already registered with Pelham Cares are eligible to receive a holiday hamper but must notify us that it is needed. Individuals and families can register for JUST the holiday hamper using the same process as required for registered clients.
- Providing gifts for parents of registered client families, to give their children at birthday time. An appropriate gift can be selected from our 'gift room' and is based on availability."
- Responding to Pelham families experiencing a home fire or other catastrophic loss, by providing emergency food, personal hygiene and household supplies, gas card, and referrals for additional services.

Greg also briefly shared with the committee about the One More Bite program. Launched in 2018 in partnership with Metro Ontario, One More Bite is a retail food recovery program that ensures much needed fresh, healthy food gets into the hands of those who need it the most. Working with Metro and Food Basics stores across the province, this program ensures food that may have otherwise gone to waste is recovered by Ontario food banks. Unsold products including meat, prepared meals, dairy, and bakery products are saved, frozen, and redistributed to local food banks to support people in need.
